
### Wisconsin Veteran Suicide Deaths, 2018


Sex	Veteran Suicides

## Veterans Use of VA Healthcare

- Less than 30% of Veterans use VA healthcare in the US and Wis.
- In Wisconsin, our Veteran population has a:
  - lower household income.
  - higher percentage of Vietnam Veterans (so generally an older population).
  - racially and culturally more diverse Veteran population in primarily in southeastern Wisconsin.







In 2003, Garza was selected to cross rate into the Intelligence Community and attended the Basic Reserve Intelligence Training (BRIT) School at NAS JRB Fort Worth, TX. He was assigned to US JICSOUTH 0270 upon completion of that course in May 2004.

In January 2005, Garza was selected for a Direct Commission as an Intelligence Officer and assigned to Reserve Intelligence Area Southeast (RIASE) New Orleans with Defense Intelligence Agency Headquarters (DIA HQ) 1482. He served as the Training Officer and Command Fitness Leader and was instrumental in RIASE assistance and recovery phases during Hurricanes Katrina and Rita in August and September 2005.
